The book describes the Forensic Assessment Interview Technique (FAINT) and Integrated Interrogation Technique (IIT) developed by the authors at their Academy for Scientific Investigative Training. FAINT is applicable to all forensic type interview where the interviewer is attempting to make a determination of the interviewee's truthfulness concerning a specific area of inquiry. It can be, and is used by law enforcement and intelligence agencies, parole and probation officers, psychologists and therapists, security and private investigators, the legal and business communities.
